The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. ## Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Dunham Charter School (TK–6th grade) conducted multiple levels of input from stakeholders. Parents were surveyed about which Expanded Learning Opportunities (ELO) would make the biggest impact. Initial ideas of activities, services and programs were shared at a meeting with all certificated and classified staff and ideas and feedback was sought. The School Site Council (parents, classified & certificated staff) also reviewed the plan and offered feedback on it. The ELO plan was presented to the Board of Trustees in open session at a Special Board meeting.

This plan is focused on meeting the learning needs and best serving all students, with a focus on students demonstrating needs for learning recovery, low income students, English Learners, students at risk of abuse, neglect, and disengaged students. The school currently has no homeless or foster youth students.

A description of how students will be identified and the needs of students will be assessed.

Students will be assessed using District multiple assessment measures including: academic assessments and screens; progress reports and report cards; ELA and Math using Renaissance/Star Assessment; social emotional surveys and teacher observation; attendance and engagement. Periodic, ongoing assessment will continue to occur throughout the year to assess and monitor progress, both in the classroom and with standards-based assessments such as STAR and social emotional surveys and observations using the Multi-tiered system of support and student study team process.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Regular ongoing communication by the Principal via weekly newsletters; parent forums, at Back to School Night; emails; and phone calls. Classroom teachers and the Intervention Specialists will inform specific families of services for those students who, based on assessment data through parent conferences, the student study team process, and system of supports. The counselor will communicate about social emotional supports available, meet with small groups, conduct professional development, and provide parents with information and referrals.

A description of the LEA's plan to provide supplemental instruction and support.

Dunham's plan is based on the following guiding principles: a) Nurture students' healthy academic identities and emotional well-being, b) prioritize essential grade level content standards, and c) have engaging heterogeneous instruction be primary means along with targeted, flexible, small group instruction to support, intervene and challenge students as needed.

In addition to classroom teachers, intervention support in both ELA and math will provide push-in and pull-out support. Classroom aides and other support staff will provide additional student support.

We will also offer extended learning and social-emotional support during the 2022-21 summer.

The plan will:

Provide a summer school program for targeted students in grades K-5th.

Provide additional social-emotional support during the 2021-22 school year.

Provide a 0.5 FTE Intervention Teacher for the 2021-22 school year.

Provide two 0.562 FTE Classified Instructional Aides for Intervention

Provide staff professional development in areas that include trauma-informed practices, engage students and families in addressing students' social-emotional health needs, accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

All funding COVID-19 funds both from the State and Federal Governments are used to support all student learning, providing a safe and orderly environment, and providing greater student engagement in academics and extracurricular activities. Maintaining school staffing at

## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]). The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
